Counsel discussed deadlines for the May 28 and July 1 hearings. With respect to the July 1 hearing, counsel advised the Court that the complexity of the issues, the volume of briefing required, and pending discovery issues require a continuance.

The parties shall exchange all marked exhibits, which are not yet in their possession but which they intend to introduce at trial, on or before **Monday, May 20, 2013.**

IT IS FURTHER ORDERED that the revised scheduling order is **APPROVED** with the following amendments with respect to the August 5 hearing:

The City shall produce any and all expert reports to be used in connection with the August 5 hearing on or before **Friday, Jun 28, 2013 at 12:00 p.m.**

Plaintiffs, LaShawn Jones et al., and intervenor plaintiff, the United States of America, shall produce any and all expert reports to be used in connection with the August 5 hearing on or before **Monday, July 15, 2013.**

The parties shall submit proposed findings of fact and conclusions of law on or before **Friday, July 19, 2013.**

IT IS FURTHER ORDERED that the motion¹ to compel and the motion² to expedite are **DISMISSED AS MOOT.**
