Full-Time U.S. Magistrate Judge
United States District Court
Eastern District of Louisiana

Subject to the approval of the Committee on the Administration of the Magistrate Judges System and the Fifth Circuit Judicial Council, the United States District Court for the Eastern District of Louisiana will fill a vacancy in the position of United States Magistrate Judge for the Eastern District of Louisiana. The position will be available January 6, 2019.

The duties of the position are demanding and wide-ranging: (1) conduct of most preliminary proceedings in criminal cases; (2) trial and disposition of misdemeanor cases; (3) conduct of various pretrial matters and evidentiary proceedings on delegation from the judges of the district court; and (4) trial and disposition of civil cases upon consent of the litigants. The basic jurisdiction of the United States magistrate judge is specified in 28 U.S.C. § 636.

To be qualified for appointment an applicant must

- (1) Be, and have been for at least five years, a member in good standing of the bar of the highest court of a state, the District of Columbia, the Commonwealth of Puerto Rico, or the Virgin Islands of the United States, and have been engaged in the active practice of law for a period of at least five years (with some substitutes authorized).
- (2) Be competent to perform all the duties of the office; be of good moral character; be emotionally stable and mature; be committed to equal justice under the law; be in good health; be patient and courteous; and be capable of deliberation and decisiveness when required to act on own reason and judgment.
- (3) Be less than seventy (70) years old.
- (4) Not be related to a judge of the district court.

A Merit Selection Panel composed of attorneys and other members of the community will review all applicants and recommend to the judges of the district court in confidence the persons it considers best qualified. The court will make the appointment, following an FBI full-field investigation and an IRS tax check of the appointee. The individual selected must comply with the financial disclosure requirements pursuant to the Ethics in Government Act of 1978, Pub. L. No. 95-

521, 90 Stat. 1824 (1978) (codified at 5 U.S.C. app. 4 §§ 101-111) as implemented by the Judicial Conference of the United States. An affirmative effort will be made to give due consideration to all qualified candidates, without regard to race, color, age, gender, religion, national origin, or disability. The current annual salary of the position is \$191,360. The term of office is eight (8) years.

Applications must be submitted only by potential nominees personally and must be received by May 18, 2018. Applicants are requested to submit thirteen (13) copies of the application.
